כלכלי תל אביב: בית המשפט יבחן את האיסורים בגינת הרשות לניירות ערך מטילה עיצום כספי בהתאם לכללי הפרשנות של הדין הפלילי, בשינויים המחויבים.
ב. יש להניח תשתית מספקת לטענת אכיפה בררנית ואין די בהעלאת סימני שאלה לגביה
העליון: אין די לעורר טענת אכיפה בררנית כטענה כללית. יש להניח תשתית מספקת להוכחת הטענה.
- 4. עדכוני משפט מסחרי, מקרקעין וזכויות יוצרים:**
א. פיצוי בגין עוולת מצג שווא רשלני הינו פיצוי הסתמכות
העליון: הפיצוי על מצג שווא רשלני הוא פיצוי הסתמכות; קנה המידה הוא העמדת הניזוק במצב שהיה בו אילוילי מצג השווא.
ב. פסק דין הגורם נזק בלתי הפיך יעוכב ביצועו ככל שקיים סיכוי קלוש לערעור
העליון: ככל שביצוע החלטת בית המשפט יגרום נזק בלתי הפיך יעוכב הביצוע אם יש סיכוי קלוש לערעור; גילוי מסמכי מכרז עשוי לגרום נזק בלתי הפיך.
ג. רק הוכחת ודאות קרובה לשיבוש משמעותי בפעילות הרשות תצדיק מניעת פרסום מידע ציבורי מלא
העליון: על מנת למנוע פרסום מידע מלא על ידי רשות נדרשת הוכחת ודאות קרובה לכך שפרסום המידע עלול לגרום לשיבוש ממשי ומשמעותי בתפקודה התקין של הרשות הציבורית.

3. תאגידים, הגבלים עסקיים וניירות ערך

א. על הליכי אכיפה מנהלית על ידי רשות יחולו הכללים הפרשניים החלים על במשפט הפלילי [עתמ (ת"א) 30045-02-12 מנועי בית שמש אחזקות (1997) בע"מ נ' יו"ר רשות לניירות, 08.08.12, המחלקה הכלכלית בבית המשפט המחוזי בתל אביב - יפו, כב' השופטת רות רונן]

חברה דיווחה על מינוי דירקטור, על אף שהליך המינוי נעשה בדרך שגויה. במסגרת הליך אכיפה מנהלית הטילה הרשות לניירות הערך עיצום כספי על החברה תחת עילה של 'אי דיווח'. החברה ערערה על החלטת הרשות לבית המשפט תוך שטענה, כי אין לראות דיווח שגוי כ'אי דיווח' שבגינה רשאית הרשות להטיל עיצום כספי.

בית המשפט החיל את העקרונות הפרשניים של המשפט הפלילי על הליך של אכיפה מנהלית וחזר על הכלל הפלילי לפיו אין עונשין אלא אם כן מזהירין, והכלל לפיו יש להעדיף את הפירוש המקל על פני זה המחמיר. הפרה תיחשב כמצב של אי דיווח ולא כמצב של דיווח מוטעה על מינוי חסר תוקף, ומכאן שחובת דיווח כלל לא הייתה קיימת במקרה דנן. כך, בית המשפט ביטל את העיצום הכספי שהטילה הרשות על החברה.

ב. יש להניח תשתית מספקת לטענת אכיפה בבררנית ואין די בהעלאת סימני שאלה לגביה [ע"פ 8551/11 יצחק כהן סלכגי ואח' נ' מדינת ישראל, בית המשפט העליון, 12.08.2012, כב' השופטים סלים ג'ובראן, יורם דנציגר, דפנה ברק-ארז]

בעלים של משרד פרסום פירסם מוצרים שנמכרו תוך הפרת סימני מסחר. נגד בעלי המשרד והמשרד עצמו נפתח הליך פלילי ואלה הורשעו בו. במסגרת ערעורם נטען כי עומדת לבעל המשרד טענת הגנה מן הצדק בשל אכיפה בבררנית שהופעלה נגדו - במקרים דומים פסקו בתי המשפט באופן שונה מזה שנפסק בעניינו. בית המשפט דחה את טענת האכיפה הבררנית וקבע כי בעלי המשרד לא זימן עדים ולא הציג נתונים שיבססו את הטענה ומשכך, אין לקבוע האם התנהלות המדינה הייתה שרירותית, מפלה או לא הוגנת. בית המשפט ציין בפסק דינו את ספרה "אכיפה סלקטיבית" של ד"ר מיכל טמיר ממשרד אפיק תורג'מן וקבע כי הגישה הנוהגת במשפט ביחס להפליה מסתפקת בהוכחת תוצאה מפלה ואינה מחייבת הוכחת מניע פסול. עם זאת, בעניינו לא הונחה תשתית מספקת לטענת האכיפה הבררנית. משכך, בית המשפט העליון הותיר את החלטת בית המשפט המחוזי על כנה ודחה את טענת האכיפה הבררנית וכך גם הערעור כולו.

א. פיצוי בגין עוולת מצג שווא רשלני הינו פיצוי הסתמכות

[עא 8361/09 דלתא להשקעות ולמסחר (קרני שומרון) בע"מ נ' מפקד כוחות צה"ל באזור יהודה ושומרון, בית המשפט העליון, 16.08.2012, כב' השופטים סלים ג'ובראן, יורם דנציגר, מרים נאור]

חברה התקשרה עם המדינה בהסדר בו התחייבה המדינה להקצות לה שטחים. בדיעבד התברר כי האישור אותו הציגה המדינה בדבר העדר בעלות בשטחים היווה מצג שווא רשלני אשר הוביל את החברה לפעול בצורה שהסבה לה נזקים ובשל כך דרשה פיצויי הסתמכות ופיצויי קיום, אשר יעמידו אותה במצב כאילו נחתם ההסדר. בית המשפט קבע כי המדינה הציגה מצגי שווא במהלך המשא ומתן ונדרש לשאלת גובה הפיצוי.

בית המשפט העליון קבע, כי המדינה הציגה מצג שווא וניהלה את המשא והמתן בחוסר תום לב. בשל כך, חויבה המדינה בפיצוי.

לעניין גובה הפיצוי קבע בית המשפט, כי הפיצוי יקבע בהתאם למידת הסתמכות הנפגע על המצג שהוצג בפניו. קנה המידה לגובה פיצויי ההסתמכות הוא העמדת הניזוק במצב שהיה בו אילו המצג היה תואם את המציאות (ואם כלל לא היה נכנס לחוזה, פיצויי שיעמיד אותו במצב בו היה אילולי נכנס לחוזה).

בדבר פיצוי בגין הפרת חובת תום הלב קבע בית המשפט, כי יינתן פיצוי בגין ההסתמכות, אך לא בגין קיום, אשר יעמידו את הניזוק במצב בו היה אילו היה נכרת ההסדר, זאת מאחר והחברה לא הציגה ראיות המלמדות מה היה מצבה אילו היה נכרת ההסדר וכן בשל כך שמדובר בסעד חוזי הניתן במקרים חריגים בלבד.

ב. פסק דין הגורם נזק בלתי הפיך יעוכב ביצועו ככל שקיים סיכוי קלוש לערעור

[עעמ 5877/12 זלצמן אשכנזי בע"מ נ' מקאן אריקסון ואח', בית המשפט העליון, 16.08.2012, כב' השופטת עדנה ארבל]

בית המשפט קבע שעל זוכה במכרז לחשוף את מלוא מסמכי הצעתו במכרז. הזוכה ערער לבית המשפט העליון וביקש כי עד להכרעה בערעור יעוכב ביצוע ההחלטה הדורשת ממנו לחשוף המסמכים, אשר משמעה נזק בלתי הפיך.

בית המשפט העליון קבע, כי במקרה בו מדובר בסעד לביצוע פעולה (סעד בעין, להבדיל מסעד כספי) אשר תגרום לנזקים בלתי הפיכים, מספיק שיהיו לערעור סיכויים קלושים כדי להורות על עיכוב ביצוע פסק הדין עד להכרעה בערעור. במקרה זה, קבע בית המשפט, כי אי עיכוב הביצוע תגרום נזק בלתי הפיך ותייתר את הדיון בערעור ועל כן הורה על עיכוב ביצוע ההחלטה עד סיום הדיון בערעור.

ג. רק הוכחת ודאות קרובה לשיבוש משמעותי בפעילות הרשות תצדיק מניעת פרסום מידע ציבורי מלא

[עעמ 1245/12 התנועה לחופש המידע ואח' נ' משרד החינוך ואח', בית המשפט העליון, 16.08.2012, כב' המשנה לנשיא(בדימ') א. ריבלין]

משרד החינוך התנגד לפרסום תוצאות בחינות המיצ"ב על פי חתך בית ספרי. בית המשפט לעניינים מנהליים קיבל את עמדת משרד החינוך וקבע, כי הרשות רשאית לפרסם מידע חלקי אם פרסום המידע במלואו יביא להשלכות שליליות. התנועה לחופש המידע ערערה על קביעה זו. בית המשפט העליון קיבלת את הערעור במלואו וקבע כי רק כאשר קיימת ודאות קרובה לפגיעה באינטרס השמירה על תקינות פעולת הרשות הציבורית – תקום עילה מספקת להגבלת חופש המידע.

הזכות לפרטיות מול הזכות לשם טוב באינטרנט/עו"ד עדי דינג'

פנה למשרדנו אדם אשר בהמשך לכתבה שפורסמה עליו באינטרנט, פורסמו תגובות (טוקבקים) אשר פוגעות בשמו הטוב ומהוות הוצאת דיבה. אותו אדם נתקל בקשיים בזיהוי המפרסם ובכך למעשה בקושי להגן על שמו הטוב. האם קיימת דרך להגן על השם הטוב גם כשהפגיעה היא על ידי משמיץ אנונימי ברשת?

הדרך להגן על שם טוב כנגד פגיעה הינה הגשת תביעה בגין הוצאת לשון הרע. ואולם, פעמים רבות הנפגע מעוולת לשון הרע באינטרנט לא יכול לקבל לידי את פרטי המזיק מכיוון שכדי לעשות זאת הוא נדרש לצו בית המשפט אשר יחייב את ספק האינטרנט לחשוף פרטי גולשים ובכך לפגוע בפרטיותם. בתי המשפט נרתעים ממתן צווים מסוג זה ולא פעם נרשם בפסקי דין כי בתי המשפט ממתניים להסדרת הנושא בחקיקה.

חוק איסור לשון הרע בא לאזן בין שני אינטרסים נוגדים: חופש הביטוי והחופש מביטוי - זכותו של אדם לשם טוב. החוק קובע, כי אין לפרסם דבר שפרסומו עלול להשפיל, לבזות או לפגוע באדם- במקצועו או משלח ידו. כדי למנוע מצב בו מתקיים דיון שלם בשאלת קיומו של "שם טוב" ומידת הפגיעה בו ומכיוון שהוכחת מידת הנזק במקרה של הוצאת לשון הרע היא קשה ביותר, מאפשר החוק, בין היתר, לתבוע פיצויים "ללא הוכחת נזק". הסכום הקבוע בחוק עומד על תקרה של 50,000 ₪ ובהתקיים תנאים מסויימים אף כפל סכום זה. למרות זאת, בפועל פוסקים בתי המשפט פיצויים נמוכים משמעותית מהקבוע בחוק ובהתחשב בכך שגם לא נוהגים לפסוק לזוכה את מלוא הוצאותיו, נוצר מצב בו התובע בלשון הרע מוצא את עצמו בסופו של דבר מפוצה בסכום נמוך מההוצאות שהוציא לשם קיום התביעה.

לאור האמור באוקטובר, 2011, הונחה על שולחן הכנסת הצעה לתיקון החוק אשר ביקשה להגדיל את סכום הפיצוי ללא הוכחת נזק פי שישה ולאפשר למי שסבור שנפגע מפרסום לפרסם תגובתו, תוך קביעת קנס, ללא הוכחת נזק, של עד מליון וחצי ש"ח לאמצעי תקשורת שלא פרסם תגובה. ההצעה עוררה סערה ציבורית, הן בכנסת והן ובקרב הציבור שיצא להפגין ברחובות. התיקון אף זכה לכינוי - "חוק ההשתקה". בעוד שהצעת החוק נראית בעלת פוטנציאל של פגיעה קשה בזכות לחופש ביטוי ולחופש עיתונות, יש לקוות כי עצם השיח הציבורי בנושא יהווה הרתעה למפיצי הדיבה באינטרנט וייתן עידוד לבתי המשפט לפסוק סכומים גבוהים יותר לנפגעים.

כאמור, גם במצב החקיקתי הנוכחי ניתן במקרים מסוימים לחשוף פרטי גולשים ולהגיש תביעה בגין לשון הרע וניתן לקבל פיצוי בסכומים משמעותיים. יצוין, כי במקרים מסוימים מעין אלו, אתרי האינטרנט אף מוחקים תגובות בהמשך למכתב מתאים מעורך דין וכך ניתן לצמצם את הפגיעה בשם הטוב. עם זאת ולאור מורכבות הנושא מומלץ לפנות לעורך דין המתמחה בתחום.
